# Nebraska Board of Engineers and Architects Public Rulemaking Hearing Minutes January 15, 2016

#### PUBLIC RULEMAKING HEARING CONVENED

The public hearing was held at 215 Centennial Mall South, 5th Floor Large Conference Room, Lincoln, Nebraska. Chair Krejci opened the hearing at 8:30 a.m. and noted the location of the Public Meeting Statutes. Notice of the hearing was published in the Lincoln Journal Star and an affidavit of publication was provided.

The Board of Engineers and Architects held the public hearing to consider revisions and receive public testimony on proposed changes to Title 110, Nebraska Administrative Code, Rules and Regulations, Chapters 1-11. Proposed revisions to the rules and regulations follow revisions to the Engineers and Architects Act in LB 23, 2015. The majority of changes to the proposed rules and regulations were made to provide clarity and improve organization.

#### **Public Comment**

Dan Thiele, representing the Professional Engineers Coalition (PEC), testified in support of the proposed rules and regulations and recommended adoption. He thanked the Board for including PEC in discussions while reviewing and revising the rules and regulations and for the opportunity to testify at the public rulemaking hearing.

On behalf of the Board, Legislative Committee Chair Kester thanked Mr. Thiele for the cooperation of PEC in reviewing and providing feedback during the revision process of the proposed rules and regulations.

There were no other comments or written testimony in favor or opposition of the proposed rules and regulations. Nebraska State Fire Marshal Jim Heine was available at the public hearing to answer any questions if needed. There were no questions from those in attendance.

The Board will adopt the proposed rules and regulations at the regular Board meeting following the public hearing.

## Title 110, NAC, Rules and Regulations - Chapters with proposed changes

Proposed rules and regulations, Chapters 1-11, were provided in a clean and legislative format for review and consideration at the public hearing.
