Chair Kester called the meeting to order at 8:00 a.m. and noted the location of the Public Meeting Statutes. Notice of the meeting was published in the Lincoln Journal Star in compliance with the Open Meetings Act.

#### **B. MEETING REPORTS**

#### Ad Hoc Committee Reports

#### Legislative Ad Hoc Report

Legislative Liaison Lombardi reported LB299 was introduced in the 105<sup>th</sup> Legislature, 1<sup>st</sup> Session by Senator Ebke. LB299 adopts the Occupational Board Reform Act to oversee the rule and regulation process of boards and commissions which regulate occupations and professions to ensure the least restrictive regulations are used to protect consumers. AM1665 proposed by the Standing Committee of the Government Military and Veterans Affairs, tasks scrutiny of new state licensing laws and proposals by the standing committees of the legislature to which a bill is referred to.

LB1025 creates a Building Codes Advisory Committee to make recommendations to the Legislature on whether to update the state building code when a new edition of current building codes is published. The bill would make the state building code a "default" code, to be used by any county, city, or village that does not adopt a local building or construction code. Expenses for members, staff, and meetings for the Advisory Committee would be covered by the budget of the Board of Engineers and Architects. A Hearing for LB1025 is scheduled on February 13, 2018.

ED Wilbeck reported the Board's Legislative Ad Hoc Committee met via conference call on January 22, 2018, to discuss the Board's position on LB1025. A draft of proposed testimony for the hearing was submitted to the Board. ED Wilbeck will work with the Ad Hoc Legislative Committee to revise the hearing testimony as discussed.

#### **Continuing Education Ad Hoc**

ED Wilbeck stated the Continuing Education Ad Hoc Committee meeting date had been moved to February 14, 2018, at 10:00 a.m. in the Board office conference room.

#### **Software Ad Hoc Committee**

Klein reported the Software Ad Hoc Committee would bring a report to the March Board meeting.

#### Other Meeting Reports

Bostelman talked about her work on the Radon Resistant New Construction Task Force created by the Radon Resistant New Construction Act by LB9 in 2017. The task force is working on the issue of radon resistant construction standards over the next year and subsequently will develop minimum standards for radon resistant new construction. Recommendations to the Governor, the Health and Human Services Committee, and the Urban Affairs Committee, will be used in the Unicameral's 2019 legislative session.

#### C. OLD BUSINESS

#### **Database conversion update**

ED Wilbeck reported signing a new Change Order with the Office of the Chief Information Officer (OCIO) for further work on a new database in the amount of \$44,450. The completion date is projected to be March 30, 2018.

#### D. NEW BUSINESS

#### NCARB Call for 2018-19 Committees

The NCARB Board of Directors is encouraging member board members to serve on an NCARB Committee. A list of proposed FY19 committees, subcommittees, and work groups was provided. All interested members and those currently serving on committees must complete and submit the Committee Application by February 26, 2018.

#### NCEES Call for 2018-19 Committees

The President-Elect of NCEES announced he would be forming committees and task forces to help fulfill the mission of NCEES. Interested members and those already on committees are encouraged to complete the NCEES online survey by March 2 and indicate first, second, and third preferences for committee/task force assignment. Committee appointments will be emailed to selected individuals by July 1, 2018. Conzett reported the current Central Zone Vice President is not going to seek the position of NCEES President-Elect. The Central Zone will need to choose its nominee for 2018-19 president-elect at the May zone meeting. Two candidates have sent out information and additional nominations may follow. Conzett suggested the Board support the nomination of Kevin Nelson, a P.E. member of the North Dakota engineering board.

#### License expiration dates

The Board reviewed current procedures for license expiration for new licensees and those that have name changes. Licensees with last names beginning with A-K expire in odd-numbered years and those with last names beginning with L-Z expire in even years. When the period of active licensure for a new licensee is less than six months, Board staff adds two years to the expiration to push it to the next renewal period. June 30<sup>th</sup> is the cutoff date. Additionally, when a licensee's last name begins with the letters A-K and their name changes to a first letter of L-Z, the license expiration is always re-set ahead to the next renewal expiration and vice-versa.

ED Wilbeck recommended adding current procedures for license expirations to the next Board rules and regulations promulgation.
