B. MEETING REPORTS

Ad Hoc Committee Reports

Legislative

Legislative Liaison Lombardi reported the Second Session of the 105th Nebraska Legislature adjourned sine die on April 18, 2018. The Legislature considered 1,136 bills during the 2017-2018 biennium. A list of adopted bills of interest to the Board and a list of 2018 Interim Studies by Committee were provided. LB 299, which included amendment AM2674 advanced on April 18, 2018. The Governor has until April 23 to approve or veto the bill. ED Wilbeck noted some biennium budget timing concerns for costs associated with LB 299 requirements. LB 751, which changes agency duties with respect to adoption of rules and regulations and budget adjustment bills, was summarized by Lombardi.

Other Meeting Reports

Bostelman reported the Radon Resistant New Construction Task Force met in March and finalized language in a recommendation to the Governor, the Department of Health and Human Services Committee, and the Urban Affairs Committee of the Nebraska Legislature. The wording provides exemptions where architects and professional engineers need to be involved. A final copy will be forwarded to the Board. A sponsor will be sought to introduce a legislative bill in 2019.

C. OLD BUSINESS

Database conversion update

ED Wilbeck reported looking at exporting data to OnBase. The Board of Geologists is scheduled to go to production on May 30, the Board of Engineers and Architects on June 30, and the State Board of Landscape Architects on July 31.

Appointment of funded delegates for NCEES Annual Meeting

The NCEES Annual Meeting will be held August 15-18, 2018, in Scottsdale, AZ. NCEES will fund three delegates and also members who have never attended an NCEES Annual Meeting and were appointed to the Board since August 15, 2016 (24 months before the meeting). The National Council of Examiners for Engineering and Surveying (NCEES) and a test preparation company for certain NCEES exams have reached an \$800,000 settlement agreement regarding allegations of the unauthorized use of copyrighted practice questions belonging to NCEES. The agreement was finalized March 15, 2018.

The Monthly Pass/Fail Report for March 2018 for the Nebraska ARE 4.0 and 5.0 divisions showed 22 exams taken and 12 exams passed.

In the first quarter of 2018, the ARE 4.0 Yearly Pass/Fail Report showed 28 attempted exams and 15 exams passed and the ARE 5.0 Yearly Pass/Fail Report showed 28 attempted exams and 19 exams passed.

A total of 88 ARE candidates had open eligibilities as of April 1, 2018.

The FE Exam Registration Numbers and Pass Rate History Report showed a first-time pass rate of 82.8% and a retake pass rate of 40.1% for Nebraska.
