CALL TO ORDER

The meeting was held at 215 Centennial Mall South, 5th Floor Large Conference Room, Lincoln, Nebraska. Chair Krejci called the meeting to order at 8:30 a.m. and noted the location of the Public Meeting Statutes. Public Comment

Nicole Taylor addressed the Board to request approval to sit for the PE examination. She had received a deferral letter indicating the experience requirements were not met. Ms. Taylor stated she presumed the completion of three years of engineering experience and obtaining a Master's degree concurrently met the requirements. Her conclusion was based on Rule 2.3.4 which states, "Successful completion of graduate study leading to the Masters degree in engineering, which has followed a baccalaureate degree in engineering, may be used for credit for one year's experience.

Ryan Farnum thanked the Board for the opportunity to discuss the requirements to take the PE exam. He requested his application be reconsidered for approval to take the PE examination. A total of 3.3 years of full-time work experience had been obtained since graduation with an ABET accredited degree. A Master's degree was earned concurrently. Mr. Farnum stated he believed the experience met the requirements as listed within the Engineers and Architects Regulation Act and Rules and Regulations and the credit for experience for a Master's degree in this type of situation should not be discouraged.

Revised Policy 03.05 – Reimbursement of Educational Debt for Architecture Graduates

With respect to § 81-3432.01, each individual who has graduated with a NAAB-accredited architectural degree from the College of Architecture at the University of Nebraska (UNL) and establishes a record through the National Council of Architectural Registration Boards (NCARB) is eligible to be reimbursed \$100 by the Board of Engineers and Architects for qualified educational debt. In order to receive reimbursement, verification of NCARB Record establishment and graduation must be received within one year of graduation. Verification of graduation may come from NCARB or officially from UNL. Payment will be by a warrant issued by the State of Nebraska.

Architecture Items

Policy updates to use and security of ARE accepted by NCARB Board of Directors

Over the past fiscal year, NCARB's Board of Directors, in conjunction with new legal counsel, underwent a thorough review and analysis of all Council policies. As a result, the NCARB Board of Directors approved updates to the *Policy for the ARE: Use and Security* at its April meeting. The policy establishes minimum expectations for Member Boards regarding their use of the ARE. Updates included minor edits to clarify the purpose of the policy as well as better describe how candidate feedback will be provided on failed administrations.

License renewal notifications issued by NCARB

A new service recently launched for NCARB-certified architects provides a reminder of upcoming license expiration dates based on information provided in their NCARB records.

Consideration of new IDP program (Experience Portfolio Documentation Method)

The NCARB Board of Directors is considering development of a new program and is seeking input from Member Boards and other related organizations. The proposed program is intended to provide a path for completing the experience requirement for those who:

- Left the profession and would like to come back
- Did not document their IDP experience with NCARB
- Did not pursue licensure in a timely fashion, e.g. Project Managers
- Can otherwise meet licensure requirements including education and examination

Member board survey - proposed IDP Experience Portfolio Documentation Program

Board member comments for the proposed IDP Experience Portfolio Documentation Program will be emailed to ED Masters. Feedback will be discussed and edited at the September Board meeting. Comments from Member Boards will be received by NCARB through September 29th. After that date, NCARB will seek additional feedback through virtual meetings offered in October.

SELG support of ACCA recommendation (Motion 1) at NCEES Annual Meeting

Motion 1 would revise the NCEES Model Laws and Model Rules to augment the generic P.E. license with a protected S.E. title and restricted S.E. practice. This would require the engineer to obtain his/her P.E. license, then a S.E. license through the 16-hour S.E. exam. The Board rules and regulations do not require a structural engineer to obtain a P.E. license first. Currently, professional engineers may practice outside their discipline if they have the education, training and experience to do so. Nebraska voting members will vote “no” for Motion 1 at the 2015 NCEES Annual Meeting.

Expiration of legal contract (*Addressed after the Compliance Section*)

Special Assistant Attorney William Austin reported a number of reasons why he would not seek to sign a new contract with the Board for another year. He offered to continue providing services while the Board looked for new legal counsel.
