The meeting was held at 215 Centennial Mall South, 5th Floor Conference Room, Lincoln, Nebraska. Chair Kester called the meeting to order at 8:00 a.m. and noted the location of the Public Meeting Statutes. B. AD HOC COMMITTEE REPORTS

The Software Engineering Committee met on July 18, 2017. ED Wilbeck reported UN-L is beginning its second year of offering a software engineering program. After asking other licensing boards, ED Wilbeck found no complaints related to software engineering have been filed. Technology is changing quickly and creating a new set of concerns on how engineering is regulated. Documentation of the development of the software engineering exam was requested from the NCEES Director of Exams. The Committee believes the definition of engineering in N.R.S. § 81-3421 is sufficient. Conzett stated the Committee will continue to strive to promote discussion on the issue and information will be sought through industry connections. ED Wilbeck will reach out to the UN-L Software Engineering Program director and propose a Software Engineering Committee meeting in August.

The Applications/Experience Committee met on July 26, 2017. The Committee holds the position that technical competence evaluation by references helps to establish "good reputation" and is consistent with statute. ED Wilbeck provided applications for the Committee to analyze from states that have decoupled the PE exam and the experience requirement. A goal will be formalized of what satisfies the Board in relation to demonstrated engineering experience. Peters stated as well as assessing the reputation, references should be clear that experience is progressive. ED Wilbeck will begin revising the reference form for Committee members to review and comment on. The summary page for the application reviews will be updated. The next Applications/Experience Committee Meeting was tentatively scheduled for Wednesday, August 30th at 11:00 a.m.

Chair Kester requested a line item to be added at the end of Committee Reports to future agendas to give Board members an opportunity to report on meetings attended.

Champion reported he would be meeting with the NCARB Model Law Task Force on August 25-26th and noted that defining architecture was proving to be difficult. The Task Force was created to determine how NCARB Model Law can better serve Member Boards.

Isom reported working on ten questions for a monograph quiz and will take part in a virtual meeting of the NCARB Continuing Education Committee on August 16th. The Committee oversees the development, delivery, and assessment of the Architect Registration Examination (ARE) for use by the 54 US licensing boards.

Conzett reported attending the Future of Engineering Profession Summit in Omaha on July 31st and August 1st. Nearly 50 individuals attended, representing a wide range of the engineering profession. Much of the summit discussion focused on scenario planning and the Engineering Change Lab (ECL). The ECL was launched in Canada in 2015 to explore "What is the higher potential of the engineering profession to contribute to society and how can we unlock this potential?" Conzett offered to provide documentation from the meeting to members. The Board agreed it would be important to keep Conzett involved in discussions.

Governor's Executive Order No. 17-04

Governor Pete Ricketts signed an executive order on July 6, 2017, in an effort to eliminate unnecessary regulations creating barriers to business growth and better jobs in Nebraska. All state agencies were asked to immediately suspend all rulemaking until December 31, 2017. Any proposed regulation affecting public health, safety, welfare, or is time sensitive or subject to statutory deadlines shall be promulgated pursuant to the Nebraska Administrative Act. The proposed rule and regulation revisions were submitted to the Attorney General's Office on June 6, 2017.

The Attorney General's Office completed the review of Title 110, NAC, Chapters 1-4 and 6-10, and approved the proposed changes.

ED Wilbeck reported the Board's rules promulgation process began well in advance of Executive Order 17.04, and based on guidance from the Policy Research Office, a report in accordance with the order specific to the proposed rules was submitted for the Governor's review. Regulation data on Title 110 pertaining to Executive Order 17-04 was provided to the Governor's Office by the Mercatus Center. ED Wilbeck prepared an evaluation of restrictive language ratings by agency. It was noted some of the restrictive wording did not pertain to the public and it did not appear there was an accounting of context. ED Wilbeck will prepare a draft for the review of the existing agency regulations for the September meeting in response to Executive Order 17.04.

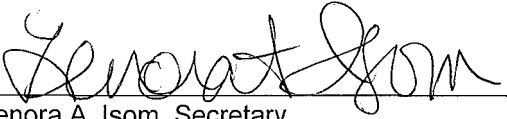
