#### 2015-16 Board committee assignments and charges

#### **Executive Committee Report**

Chair Krejci reported applications for the Compliance Officer position had been reviewed. Reviewers from the Executive Committee and Enforcement Committee will meet after the regular meeting to create a short list.

#### **Education and Communication Committee Report**

Committee Chair Helgoth reported the Continuing Education Seminar on November 13, 2015, was a success and feedback was positive. Deborah Long gave a well-received presentation on ethics. Various venues will be reviewed for the 2016 continuing education session. Education will equally address architects and professional engineers. PIO Fetterman reported the Committee had not met since the last Board meeting.

The Facebook Activity Report tracking activity on the Board's website from October 16 to November 12, 2015, was presented for review.

#### **Enforcement Committee Report**

Committee Chair Klein reported the Enforcement Committee met on November 11<sup>th</sup> and the desired attributes for a successful Compliance Officer were discussed.

The Committee continued discussion with the Board concerning guidelines on plan stamping. The question to ask may be whether the person sealing the drawing has the ability to make changes. Statute and rules will need to be applied in each case. The Compliance Officer's job will be to gather evidence on document seals. Rule 6.1.4 was cited. Statutes § 81-3450 and § 81-3454 and proposed rules 6.1.9.1 to 6.1.9.6 were reviewed. The Board will forbid plan stamping and attempt to define what it is. Current rules state what can be done rather than what cannot be done. The Committee was charged to look at cases and apply the Board's discussion. During the next rule revision, an attempt will be made to better define the issue. It was noted that responsible charge and remediation are addressed in the NCEES Model Rules.

#### **Legislative Committee Report**

Committee Chair Kester reported the public rulemaking hearing on the proposed rules would be held on December 11th. ED Masters will contact staff at the Governor's office to make sure a meeting is being scheduled by the hearing date with Governor Ricketts to discuss a cooperative arrangement between state agencies that would better serve the health, safety and welfare of Nebraska citizens. Rich Lombardi will be contacted to discuss the issue. Helgoth and Masters met with two Nebraska Department of Environmental Quality (NDEQ) administrators to discuss proposed rules and regulations. Conversation included issues with professional engineers in noncompliance with the Engineers and Architects Regulation Act for NDEQ projects. The Legislative Committee will meet to vet issues for the hearing before December 11th. ED Masters will contact stakeholders and building officials and confirm testimony in favor of the proposed rules.

An email was received from Senator Krist's office concerning sections 8.42 and 8.43 of the proposed rules. A response will be sent in writing and ED Masters and possibly Kester will meet with him.
