### **ADJOURNMENT**

#### **CALL TO ORDER**

The meeting was held at 215 Centennial Mall South, 5<sup>th</sup> Floor Conference Room, Lincoln, Nebraska. Chair Kester called the meeting to order at 8:32 a.m. and noted the location of the Public Meeting Statutes. Notice of the meeting was published in the Lincoln Journal Star in compliance with the Open Meetings Act.

**Member Roll Call:** Krista Kester, Chair; Jennifer Klein, Vice-Chair; Mark Champion; Michael Conzett; Randy Peters. Absent: Jan Bostelman; Lenora Isom, Secretary.

**Staff Present:** Jon Wilbeck, Executive Director (ED); Lindy Rauscher, Compliance Officer (CO); Sandra Weaver, Business Manager; Jean Lais, Administrative Assistant; Molly Mayhew, Public Information Officer (PIO).

#### PUBLIC COMMENT

Architect Jack Green, addressed the Board with some concerns related to completing projects in rural Nebraska. He reported seeing work which in his opinion constituted the practice of engineering often being completed by unlicensed persons. In addition, he expressed concerns related to regulation and approval of these projects by local jurisdictions and other state agencies.

In the absence of Isom, Kester appointed Conzett as Secretary for the October meeting.

Klein reported the Software Committee would bring a report to December meeting.

ED Wilbeck reported the Decoupling Committee is attempting to set up a meeting with the Nebraska Society of Professional Engineers (NSPE-NE) in November 2017.

#### Other Meeting Reports

Peters reported giving a series of engineering ethics workshops, as a representative of the University of Nebraska, to the American Council of Engineering Companies of Nebraska (ACEC-N) and the Nebraska Department of Transportation.

#### C. OLD BUSINESS

#### Draft response to Governor's Executive Order No. 17.04

ED Wilbeck provided a report draft for the Board in response to the Governor's Executive Order No. 17.04. The report is due by November 15, 2017. ED Wilbeck stated he had attended an Independent Agency meeting at the Governor's Mansion concerning the order and how agencies should comply with it. Lauren Kintner, Director of the Governor's Policy Research Office, was the speaker. ED Wilbeck will continue to refine the document before submittal.

#### SOW1062-001 Project Change Order for database

ED Wilbeck reported a project change order for the database was approved by the Director of the OCIO on October 16, 2017. The change will allow the OCIO to complete the out of scope items determined by agency analysis. The estimated cost is \$6,300 and the projected completion date is December 29, 2017.

#### D. NEW BUSINESS

#### Rules and Regulations promulgation update

ED Wilbeck announced the Governor approved the proposed changes for Title 110, NAC, Rules and Regulations on October 27, 2017. After being filed with the Secretary of State, the revised rules and regulations will become effective November 1, 2017.

#### NCARB Fast Facts - September 2017

ED Wilbeck noted the U.S. House of Representatives Judiciary Subcommittee on Regulatory Reform, Commercial and Antitrust Law held a hearing in Washington DC on occupational licensing. Prior to the hearing, NCARB signed a joint statement with other associations and organizations representing state professional licensing boards. Through the statement, the group urged the subcommittee to consider the unique role of state licensing boards in the system of state government, as well as their mission to protect the public from harm.

The September issue also contained a request for a signed Letter of Undertaking for the Tri-National Mutual Recognition Agreement for International Practice. In February 2014, NCARB implemented the agreement developed by leaders and regulators of architecture in Canada, Mexico, and the United States to facilitate mutual recognition of licensure credentials across all three countries.

The Board discussed the clarity of the language in the rule, and decided that Rule 9.2.3 needed no modification.

### NCEES Emeritus member term limit survey

The Advisory Committee on Council Activities (ACCA) was charged to review *Bylaws 3.022*, Emeritus Members, and determine if a term limit should be placed on how long an individual may serve as an NCEES emeritus member. A survey was completed by the October 20, 2017 deadline. Board reviewed the responses.

The Monthly Pass/Fail Report for September 2017 for the Nebraska ARE 4.0 and 5.0 divisions showed 12 exams attempted and five exams passed.

The 2017 Nebraska ARE 4.0 Yearly Pass/Fail Report showed 98 exams attempted and 66 exams passed as of September 2017.

The 2017 Nebraska ARE 5.0 Yearly Pass/Fail Report showed 45 exams attempted and 22 exams passed as of September 2017.
