Legislative

Legislative Liaison Lombardi reported the 105th Legislature, 2nd session would convene January 3, 2018. More than 666 pieces of legislature were introduced in the 2017 session and 22 separate pieces of legislation were monitored for the Board. Lombardi handed out a list of successful legislation and policy studies of interest. A list of 2018 legislative bills will be provided at the January Board meeting. Lombardi went over LB 299 with the Board. The bill was created to adopt the Occupational Board Reform Act and change procedures for rules and regulations. The pros and cons of decoupling work experience between the FE and PE exam were discussed. ED Wilbeck reminded the Board that implementing NCARB's Integrated Path to Licensure (IPAL) for architects would require a revision of the E&A Regulation Act.

Software

Champion reported briefly on the issues the Software Committee is dealing with. It is hoped that Klein will bring a report to the January Board meeting.

Decoupling

Decoupling issues were discussed during the Legislative Committee Report. Conzett will give ED Wilbeck an update after following up with an NSPE contact.

NCEES EPE Committee PE Software Engineering Exam recommendations/survey

The 2017-18 Committee on Examinations for Professional Engineers (EPE) was charged to recommend ways to promote the PE Software Engineering exam to member Boards. With that in mind the EPE subcommittee developed a short survey and asked that it be forwarded to member board administrators. After discussion, the Board chose to answer "Yes" to the following questions:

1. Does your state currently have a path to licensure for software engineers?
2. Would your board like support in defining the practices of licensed software engineers?

Western States Licensing Compact

Other Financial Matters

Spending restraint letter to code agency directors, agencies, boards, and commissions

The Nebraska Economic Forecasting Advisory Board revised downward the net General Fund receipt forecast from \$100 million to \$123 million. Governor Ricketts called for fiscal restraint measures. FY 2017-18 appropriations will be reduced from allotment by one percent each quarter beginning with the third fiscal quarter. Code agencies will be restricted to a hiring freeze, travel ban, limited technology and equipment purchases, and reductions in discretionary grants in aid. Non-code agencies, boards, and commissions are asked to apply the restraint measures as well.

Pay for Performance Program

On November 29th, the Governor announced the state will be implementing a new pay for performance program for discretionary and classified rules positions. Beginning January 1, 2018, "cost of living" pay increases will no longer be given. Instead, merit increases will be awarded to those that meet their goals. The pay for performance program will be implemented using existing dollars. Those exceeding established goals could be eligible for an amount above the merit raise using funds not spent for those that do not meet their goals.
