2016-17 Board committee assignments and charges

A list of 2016-17 committees and charges was provided to the Board.

Legislative Ad Hoc Committee Report

Chair Kester reported the Legislative Committee will be scheduling a conference call during the next week with representatives of the Nebraska Codes Officials Association (NCOA) for discussion of proposed exemption changes in the Engineers and Architects Regulation Act. The Board will be looking for a possible sponsor for a legislative bill.

Legislative Liaison Lombardi reported 18 days left before the election with a total of 25 seats out of the chamber's 49 seats affected. Many of the bill sponsors are in close races. The Nebraska Economic Forecasting Advisory Board (NEFAB) will meet on October 28, 2016, to review the current FY 2016-17 forecast and to make its initial estimate of the general fund tax receipts for the 2017-2019 biennium. There will be pressure on state agencies to exercise fiscal spending restraint. Allotment of appropriation has been reduced by 1% per quarter for all agencies and unspent appropriation from FY 2015-16 should be reserved for payment of prior year obligations or justified one-time expense. The Board discussed possible sponsors to carry its bill in the 2017 Legislative Session. Final selection of a sponsor will need to wait until after the election. ED Wilbeck reported additional meetings and communication will take place with stakeholders.

C Old Business

2016 Licensing Ceremony update

PIO Dittmar reported the New Licensee Ceremony scheduled for November 4, 2016, was moved to 3:00 p.m. since the alternate location for the reception is being used by another agency until 4:00 p.m. Conzett will give the keynote address and AIA President Barb Gay and NSPE Chapter President Matt Kruse and will serve as the speakers for the presentation of architects and engineers. Isom and Helgoth will read the names and bios of the honorees. The caterer and photographer have been confirmed.

Doane University engineering program update

Helgoth reported the University of Nebraska was working with other colleges in the state to promote its 3-2 program and would be meeting with Doane University. ED Wilbeck and the Board will continue to offer their support.

Licensing database update

ED Wilbeck reported there were eight responses to the request for information (RFI) and seven software vendors were chosen to give half-day demonstrations. The software demonstrations were attended during the past few weeks and ended on October 18th. The Office of the Chief Information Officer (OCIO) will write a request for proposal (RFP). A maximum level of acceptable expenditures for a new database will be determined for discussions with the Office of the Chief Information Officer (OCIO) when considering a vendor.

The completed nomination package must be received at NCEES headquarters no later than January 31, 2017.

Structural Engineering Certification Board Education Certificate for students

The Board reviewed a voluntary program prepared for schools by the Structural Engineers Certification Board (SECB) to assist interested students in beginning the journey to receive an education certificate. Some concern was expressed that this certification might cause confusion since it is not connected to licensure.

A memorandum sent to all agencies, boards and commissions by Governor Pete Ricketts on October 14, 2016, asked agency directors and members of boards and commissions to exercise additional fiscal restraint expected of the members of his cabinet because of the tax receipt shortfall. In a previous memorandum in July, it was reported the State Budget Division had been instructed to reduce allotments of FY 2016-17 appropriations by 1% per quarter. Any FY 2015-16 appropriations unspent by state agencies on June 30, 2016, will be reserved for payment of prior year obligations or a justified one-time expense.

Governor's fiscal restraint memorandum to code agency directors

A spending restraint memorandum was sent to Code Agency Directors on October 14, 2016, instructing additional spending restraints as follows:

- Hiring Freeze: Only refill positions that are mission critical to the effective delivery of services.
- Travel Ban: Eliminate all non-essential out-of-state travel.
- **Technology and Equipment:** Limit technology and equipment purchases to that necessary for continued service delivery or to achieve immediate operational savings.
- Grants in Aid: Reduce or defer discretionary distributions of grants in aid.
