PIO Mayhew summarized outreach communications to various organizations. On January 14, 2019, a presentation was delivered to the Nebraska Growers and Brewers Conference on when licensees are required. A table will be manned at the UN-L engineering library for a day during E-Week, which begins on February 17, 2019, to promote licensure and offer information about the Board. An Instagram targeted toward students has been created and a U-Tube infographic video is being developed to explain the Engineers and Architects Regulation Act and the exemption matrix in the rules and regulations. PIO Mayhew and CO Rauscher will give a presentation on when licensees are required at the Nebraska Planning and Zoning Association (NPZA) in Kearney, Nebraska, on March 7, 2019. On March 13, 2019, Hastings Community College students will be given a presentation at the Board office on when licensees are required for a project. On March 14, 2019, ED Wilbeck will give a presentation promoting licensure to a UN-L architectural class.

The Board's Facebook Analytics Report showed 651 individuals engaged from January 7, 2019, to February 3, 2019.

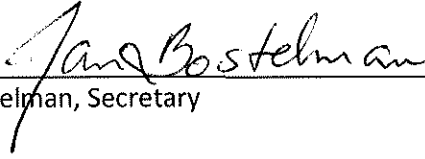
