Other Old Business

ED Wilbeck reported communicating with Gary Bowen, who is leading an effort to obtain a Governor's proclamation in honor of Thomas Kimball. The proclamation would be in conjunction with Kimball's induction into the Nebraska Hall of Fame at the State Capitol on June 25, 2019. The State of Nebraska did not start issuing architect licenses until the Board was established in 1937, which was three years after Kimball's death. The Board discussed awarding an honorary posthumous architect license to honor Thomas Kimball at the induction ceremony.

Proposed disclosure language for license renewals

Disclosure questions for architect or professional engineer license renewal applications were revised to eliminate unnecessary repetition of disclosure submittals. The revised questions would be effective for December 31, 2018 and December 31, 2019 license renewals as soon as the online license renewal site is updated. Disclosure questions would not change for exam, engineer intern, license, temporary permit, and reinstatement applications, allowing the Board to capture a full history for each applicant. Proposed revisions for the disclosure questions for license renewals were reviewed as follows:

- Are there now any criminal charges, other than a minor traffic violation, pending against you in this or any other jurisdiction?
- Is there any action or proceeding presently pending against you in any court or other tribunal in this or any other jurisdiction alleging that you committed fraud, misrepresentation, or professional malpractice?
- During the past two years, have you been denied a license to practice in this or any other jurisdiction?
- During the past two years, has a complaint been filed or has formal disciplinary action been taken against you by a regulatory body for professional engineering or architecture in this or any other jurisdiction?
- During the past two years, have you voluntarily surrendered your architect or professional engineer license or entered into a negotiated settlement in order to avoid disciplinary action by a professional regulatory body in this or any other jurisdiction?
- During the past two years, have you been convicted of a crime, other than a minor traffic violation, in this or any other jurisdiction?
- During the past two years, have you entered into a pretrial diversion program or similar pretrial procedure to avoid prosecution for a crime, other than a minor traffic violation, in this or any other jurisdiction?
- During the past two years, has a judgment been entered against you in a civil proceeding in this or any other jurisdiction involving fraud, misrepresentation, or professional malpractice?
