Legislative Committee

A list of bills for the 2022-23 legislative session that may be of interest to the Board was provided by Catalyst Public Affairs. A list of the legislative committees and their members was also provided. Bills of note include:

- LB16 Revision to the Occupational Board Reform Act to require licensure of individuals who are
 licensed or certified in another jurisdiction if they meet certain requirements regardless of whether they
 meet Nebraska's requirements or not. Professions regulated by the Board of Engineers and Architects
 would be exempt from the requirement.
- LB102 Changes to the provisions of the Land Surveyors Regulation Act and the Nebraska Plan Coordinate System Act
- LB471 Creation of a voluntary registry of interior designers and changes to the Engineers & Architects
 Act
- LB628 Change provisions relating to the professional services by limited liability companies and professional corporations
- LB684 Requires the Department of Administrative Services to contract with an outside entity to conduct a review of all services provided by state agencies over a two-year period and provide recommendations to the legislature.

Interior Design Committee

A draft copy of the proposed bill language was provided. The bill would create a voluntary registry of interior designers who meet certain requirements and add the profession to the Board of Engineers and Architects with two additional board seats. ED Wilbeck provided a draft fiscal note with the estimated cost of adding the registry. Estimated expenditures for FY2023-24 are \$140,614 and \$55,500 for FY2024-25. This includes adding an Administrative Programs Officer I position, CIDQ annual membership, travel, rules promulgation, form development, and expenses related to the change in the Board's name.

LB471 was introduced on January 17, 2023, with the provided draft language.

ED Wilbeck discussed some of his concerns with the bill:

- The bill does not address the unlicensed practice of registered interior design. As such, the definition of interior design is not needed. In addition, the definition is different from the language introduced in AM43 in 2022 which had been agreed upon by both the Board and ASID.
- If it is not unlawful to practice interior design without being registered, a seal is not required. The bill does not require documents or submittals to be sealed and does not list when a seal is to be applied.
- The bill does not define what an interior designer can do, only what registered interior design encompasses.
- The qualifications for the interior designer members call for the individual to be engaged in the active practice of registered interior design for at least ten years at the time of the member's appointment. As the registry is being created by LB471, no persons would be able to fulfill this requirement.

Meetings have been held with the interior designers and Senator Geist's officer regarding what the interior designers want to achieve. If they want to use the definition of interior design, the bill becomes more of a practice and license act. If are interested in only creating a registry, the bill becomes a title act. A title act could be used to gauge the interest of interior designers in becoming licensed. Discussions have also taken place to hold off with a practice act until the Interorganizational Council on Regulation (ICOR) Task Force has completed its work on defining each of the professions and identifying areas of practice overlap between architecture, engineering, landscape architecture, and interior design.

Compliance may be an issue if there is no requirement that only a registered interior designer can perform registered interior design. If a registrant was brought before the board for the unlicensed practice of architecture, they could claim they were not practicing architecture, but registered interior design.

The members also discussed the need to have additional interior design members if only a title act. If new members were added should be in an ex-officio position.

The Board requested ED Wilbeck ask Special Assistant Attorney General Minahan to review the bill and provided a summary of conflicts found in the bill when looking at a practice vs. title act.

D. NEW BUSINESS

H.R. 7939

H.R. 7939 was signed into law by President Biden on January 5, 2023. The bill requires licensing jurisdictions to issue/recognize a license from another jurisdiction of like practice for military personnel or their spouses when relocated due to military orders. The licensee must provide evidence of:

- Military orders;
- Be in good standing in the issuing jurisdiction;
- Evidence the license has been used during the two years immediately preceding the relocation; and
- Submit to the authority of the licensing authority in the new jurisdiction for the purposes of standards of practice, discipline, and fulfillment of any continuing education requirements

NCARB Rolling Clock Discussions

The NCARB Examination Committee has been charged with reviewing the ARE Rolling Clock and extension policies. The Board of Directors discussed the policy at its fall and January meetings. There has been concern raised that the policy may be causing barriers, especially for women and people of color. No decision or resolution has been made.

Nebraska has not codified the rolling clock in statute or rules, only stating that the exam must be taken in accordance with NCARB's policies.

Suelter indicated NCEES is also looking into the five-year window related to the structural engineering (SE) exam. There have been approximately 34,000 (SE) exams given since 2008 and only 1.5% of the candidates have been affected by the policy.
