#### **CALL TO ORDER**

The June 9, 2023, meeting of the Nebraska Board of Engineers and Architects was held in the fifth-floor conference room, 215 Centennial Mall South, Lincoln, Nebraska. Vice-Chair Suelter called the meeting to order at 8:33 a.m. and noted the location of the Open Meetings Act. Notice of the meeting was published in the Lincoln Journal Star in compliance with the Open Meetings Act.

## **PUBLIC COMMENT**

Melissa Ficke, Catalyst Public Affairs, provided an end-of-the-session legislative report. The session adjourned June 1st. There were 820 bills introduced, with 291 bills passed in 31 packages. There were 107 priority bills, of which 72 passed.

Ficke recommended meeting with Senator Bosn regarding LB471 over the interim. While she is not on the Government, Military, and Veteran's Affairs (GMVA) Committee, she has Geist's staff. She also suggested the Board meeting with committee members, other senators, and the Governor's staff.

Senator Brewer introduced LR221 calling for an interim study on how interior designer regulation would fit within the Occupational Board Reform Act. ED Wilbeck will reach out to Dick Clark, legal counsel for the GMVA Committee, to set up a meeting.

Senator Brewer also introduced LR222 calling for an interim study on how landscape architects regulations fits into the Occupational Board Reform Act. According to APO Lais, the State Board of Landscape Architects has reached out to the senator's office, but no response has been received. It is unclear if the study is related to LR221. It may be related to the required five-year rules review required by the Occupational Reform Board Act as it has not gone through the review to date.
