A copy of LR 221 was provided. The resolution calls for an interim study to review the credentialing requirements for interior designers for the purposes of the Occupational Board Reform Act. A hearing has been scheduled for September 22, 2023. ED Wilbeck and Catalyst Public Affairs are working on scheduling a meeting with Dick Clark, legal counsel for the Government, Military, and Veterans Affairs (GVMA) committee, to further discuss and lend any assistance to the committee.

Ficke and ED Wilbeck will be meeting with Dick Clark, legal counsel for the GVMA committee, on August 11th to discuss the Board's position with the current language of LB471.

##### [Rules Committee](#)

A current copy of the purposed rules from the Rules Committee was provided along with communication between the committee members. A discussion was held on the following:

#### Chapter 9 – Continuing Education

CO Habe received an inquiry for clarification for seminars that are on demand, but have staff running the presentation as questions are asked during the presentation to confirm an individual is participating. There is a test given at the end once the timer has run out, and credit is not given until it is passed. Per discussion, this type of presentation is restricted per Rule 9.3.1.

Dvorak stated interaction with other professionals is important in maintaining competency and requested the Board look into other interactive activities that may be added to continuing education (CE) in the future.

A discussion was held on revision and determining hours for activities such as examination item development, serving in professional technical or professional societies, and outreach activities listed in Rule 9.2.3. The

**C. OLD BUSINESS**

[Database Replacement Project w/NCARB](#)

ED Wilbeck updated the members on the progress of the project. Testing on landscape architect renewals is scheduled for August 17-29, 2023. The go-live date is on schedule for mid to late September.

Licensing Systems/Stripe allows for credit/debit, ACH, or paper check payments. A flow chart showing the application submittal process based on the payment method was provided. Discussion was held regarding accepting paper checks. After discussion, it was decided to require applicants who want to pay with a check or money order will need to submit a paper application. Applicants will not be permitted to submit an application online and then submit the payment in paper form.

Discussion was also held on the information the members would like to see on applications in the meeting materials. ED Wilbeck provided an example from NCARB showing information on an applicant with an NCARB certificate. The members would like to continue seeing the same information currently provided, but would be ok receiving only the information provided in the example unless there is an exception that needs further board review.
