This matter comes on for hearing on August 2, 2024. Testimony was heard and evidence was received. Based on the testimony and evidence received, the Nebraska Board of Engineers and Architects (the "Board") finds and rules as follows:

THE PARTIES

- 1. Respondent, Robert Nangia (E-12795), is an individual who holds a license in the State of Nebraska for the practice of professional engineering.
- 2. Complainant, the Board, was created by the State of Nebraska to oversee the laws and rules which govern the practice of engineering and architecture in the state in order to safeguard life, health, property and promote public welfare pursuant to Neb. Rev. Stat. §§ 81-3401 81-3455 and Title 110 of the Nebraska Administrative Code.

FINDINGS OF FACT

3. On or about February 1, 2024, the Respondent notified the Board that Respondent had signed a settlement agreement with the Missouri Board for Architects, Professional Engineers, Professional Land Surveyors, and Professional Landscape Architects ("Missouri Board").

4. The Missouri Board found and Respondent acknowledged, that on June 26, 2016, Respondent had entered into a consent agreement with the Oklahoma State Board of Licensure for Professional Engineers and Land Surveyors, wherein Respondent was assessed an administrative penalty and ordered to complete an educational program. Thereafter, several other states took reciprocal action. In addition, the Missouri Board found, and Respondent acknowledged that Respondent failed to report the disciplinary actions upon renewing Respondent's Missouri PE license on December 25, 2017, December 23, 2019, and December 23, 2021. As part of the settlement agreement, the Missouri Board and Respondent entered a Joint Agreed Disciplinary Order placing Respondent's Missouri license on probation for a period of three (3) years and perform certain obligations as further outlined in the settlement agreement.

CONCLUSIONS OF LAW

- 5. Pursuant to Neb. Admin. Code Title 110 1.18.4 the Board is required to review disclosures regarding probation of a professional engineer license in another jurisdiction.
- 6. Based upon such review, the Board finds that Respondent is in violation of Neb. Admin. Code Title 110 5.4.1 and 5.4.3. and is subject to Disciplinary Action pursuant to Neb. Admin. Code Title 110 5.4.3.1.

ORDER

UPON THE EXECUTION OF THIS ORDER BY EXECUTIVE DIRECTOR JON WILBECK AS AUTHORIZED BY THE BOARD, THE BOARD DOES HEREBY ORDER THE FOLLOWING:

7. Respondent's professional engineering license (E-12795) is hereby placed on probation for the time period concurrent with the Missouri Board's probationary period of Respondent's Missouri professional license.

- 8. While under probation, Respondent shall comply with all terms of the Missouri probation requirements and failure to properly comply with such terms will be considered a violation of this Order nd may result in additional discipline.
 - 9. Respondent is charged with the costs of this matter in the following amounts:

The Costs shall be paid within 30 days of the Board's execution of this Settlement

Agreement. Failure to pay the allocated costs will be considered a violation of this Settlement

Agreement and may result in additional discipline.
