Governor's FY2025-27 Executive Budget Summary

LB261 was introduced with the Governor's 2025-27 biennium budget recommendations. The only increases recommended were for staff Payroll, Salaries, Labor (PSL) for staff, and insurance. No increases were included for travel expenses, board member per diem, funds related to the database conversion, or general operating costs.

As noted above, LB264 proposes a transfer of \$400,000 from the Engineers and Architects Regulation Fund to the state General Fund.

C. OLD BUSINESS

Rules Promulgation Discussion and Adoption

Based on the comments received, ED Wilbeck provided the following proposed revisions. As a result, the current rules promulgation is being terminated and will be restarted with a new hearing scheduled.

Rule 1.18.4 – The rule is being revised to include organization disclosures in the actions that can be reviewed at the staff level. Revised language: "...disclosure statements provided by applicants and organizations during any application process...However, the Board must review disclosures which an applicant or organization which have not already been disclosed..."

Rule 4.1.5 – Add the requirement that the international licensee must be on the International Professional Engineer Registry in order to qualify for licensure.

Rule 4.1.2.4 – Revision to add "of ABET" after Engineering Technology Accreditation Committee.

Rule 5.3.3 – Insert "of discovering a suspected violation" after "90 days".

Rule 9.3.1 – Add AIA-approved providers to the list of web-based providers courses that may constitute all of the biennial education requirements.

Rule 9.3.6 – change "24-hour period" to "any calendar day"
