

## CALL TO ORDER

The July 11, 2025, Nebraska Board of Engineers and Architects (NBEA) meeting was held in the Morrill Room at 301 Centennial Mall South, Lincoln, Nebraska. Chair Dvorak called the meeting to order at 8:30 a.m. and noted the location of the Open Meetings Act. Notice of the meeting was published in the Lincoln Journal Star in compliance with the Open Meetings Act.

## Public Comment

Jeanne McClure, Executive Director – American Council of Engineering Companies (ACEC) McClure discussed testifying before the Appropriations Committee opposing the \$400,000 transfer from the Board’s Cash Fund into the General Fund. She suggested that if the Board is looking to lower the Cash Fund, it consider a fee holiday or discount.

She highlighted some of the projects ACEC is currently working on, which include:

- A mentoring program for freshman and sophomore civil engineering students.
- Partnering with the Engineering Club in Lincoln and Omaha for Bingo events to help raise funds for scholarships. The events have raised over \$90,000 in the last three years.
- Creating videos geared for K-12 with a focus on built projects. Each video is a maximum of five minutes and is structured for each age group. The videos will be released on the ACES website and promoted through the Nebraska Department of Education’s Skilled and Technical Sciences Division.
- Creating PowerPoint presentations on civil engineering, which will be published on ACEC’s website.
- Partnering with Lincoln Literacy to assist with employment. The program connects them with licensees and resources to work through the licensure process, including the education evaluation process, instructing them on what they can and cannot do without a license.

## C. OLD BUSINESS

### Feedback related to E&A Act Coordinating Professional Provisions

At the Operational Planning meeting on May 30, 2025, the Board discussed the possibility of removing the requirement for coordinating professionals from the E&A Act and Rules. The members requested ED Wilbeck contact the professional societies and other state agencies to obtain information as to how the requirement has impacted their practices. Responses have been received from the Nebraska Society of Professional Engineers (NeSPE), Nebraska Association of County Officials (NACO), Nebraska State Fire Marshal (SFM), Associated General Contractors, Professional Engineers Coalition (PEC), American Institute of Architects – Nebraska Chapter (AIA-NE), American Council of Engineering Companies (ACEC), and Pat Leahy, Architect.

### Discussion with State Treasurer on Interior Design Registry

Correspondence between ED Wilbeck and the State Treasurer’s office was provided. Deputy State Treasurer Jason Walters indicated he would attend the October 24, 2025, meeting to discuss the Board’s concerns regarding the interior designer seal.

### Potential Changes to E&A Act and Board Rules based on Operational Planning discussion

Per the discussion at the May 30, 2025, Operational Planning meeting, ED Wilbeck provided proposed statutory and Rules revisions. After further discussion, the following revisions were agreed upon. The members directed ED Wilbeck to convey the revisions to the stakeholders for comment.

- **81-3408, 81-3437.02, and Rule 6.3.** The Board considered making changes to coordination professional requirements, however, after receiving feedback from stakeholder groups, the board determined the provision should not be removed or altered.
- **81-3737.01(2)** would be rewritten to clarify how a signature is to be applied in conjunction with a licensee’s seal. *Whenever the seal is applied, the licensee’s signature and date shall be either across or adjacent to the seal. If applied across the seal, the signature and date shall not obscure the licensee’s name or license number on the seal. The board may adopt and promulgate rules and regulations for application of the seal.*
- **81-3449(10)** provisions allowing architects who hold a National Council of Architectural Registration Boards (NCARB) certificate to offer to practice in Nebraska upon notifying the Board they intend to do so should be deleted. The provision was added when it was introduced in NCARB model law, and since been removed.

- **81-3451** would be revised to allow for direct registration with NCEES for PE exam candidates whose results are reported to Nebraska. This will remove the requirement of first requiring Board approval to register and sit for the exam. As a result, the requirements for initial licensure are being revised as they currently point to meeting the requirements of being approved to sit for the PE exam.
- **Rule 1.12.1** The provision that an application fee paid and not used for that purpose may be used as a credit on another application would be removed as the new database does not have the capability of doing so. As a result, if the incorrect application fee is paid, it will be forfeited, and the correct fee must still be submitted.
- **Rules 2.4.1.2, 2.4.2, and 2.4.4:** With the removal of Board approval for the PE exam in Neb. Rev. Stat. § 81-3451, the Board will no longer determine the applicant's eligibility; therefore, the rules should be removed.
- **Rule 2.8.1** should be revised to remove the requirement that the exam candidate must pass the exam on the first attempt. The amount of the reimbursement should be increased to \$225. It was further suggested that the amount be removed and replaced with a statement that the reimbursement amount will be set on an annual basis by the Board or the current cost of the FE exam registration with NCEES.
- **Rule 3.7.1** should be revised to increase the amount of the reimbursement to \$225. It was further suggested that the amount be removed and replaced with a statement that the reimbursement amount will be set on an annual basis by the Board.
- **Rule 7.3.6** should be revised to clarify when an organization must notify the Board of any changes in contact information or the organization's name. ...*Organizations holding a certificate of authorization must notify the board in writing within 30 days after a change in the organization's physical or mailing address, electronic mail address, telephone number, other contact information, or operation, including name changes and dissolution of the organization.*
- **Rule 8.6.1**, regarding collection of in arrears certificate of authorization fees, should be moved to Chapter 7.

Discussion was held on the timing of a bill introduction. ED Wilbeck met with Russell Westerhold from Edwards, Westerhold, and Moore (legislative liaison) regarding the introduction. ED Wilbeck will meet with him again to discuss further. The members also directed ED Wilbeck to communicate the revisions to the stakeholders for comment.

As part of the feedback received on coordinating professional requirements, attendees at the June Nebraska Association of County Officials (NACO) conference inquired if they could be notified when a complaint was filed within their jurisdictions. ED Wilbeck will follow up with the attorney general's office to determine what and/or when a building official could be notified of a complaint in their jurisdiction.

### [Occupancy Classification Question](#)

Additional clarification has been requested regarding the occupancy classification for townhouses. After the discussion, the members held to the determination at the May meeting that if they share structural elements, regardless of the firewall, and are over 10,000 sq ft or there are five or more units, the project is subject to the E&A Act.

### [Update on Licensee Database Replacement Project w/NCARB](#)

The database replacement project meeting notes from July 1, 2025, were provided. ED Wilbeck reported that the templates for all engineering credentials are set up in the new database, and he is currently working on setting up the applications. He has also begun work on the architectural credentials.

## D. NEW BUSINESS

### Discussion of Motions to be Presented at the 2025 NCEES Annual Meeting

A copy of the action items to be presented at the 2025 NCEES Annual Meeting in New Orleans on August 19-22, 2025, was provided. After the discussion, the members agreed with the NCEES Board of Directors' positions on all action items with the exception of Licensure Motion 1. After review, the Board felt the rubric format may set the competency too high. The result may actually discourage and cause a barrier to licensure. Licensing boards' goal is to determine minimum competency.

### FY25/26 Health Insurance Increases

A memo from the Department of Administrative Services (DAS) regarding an increase in the agency's share of health insurance premiums was provided. Due to increased costs and higher-than-expected claims in the last biennium, agencies will be required to contribute an additional 18.5% of the premium costs for a total of 81.7%. This results in an additional \$3,100 in health insurance costs for FY25-26.

### Certificate of Authorization Exemption Request

A request was received from *Arrow Tank and Engineering Company LLC* to allow the use of the term 'engineering' in the organization's trade name.

### Request for Board discussion of rules regarding experience credit for advanced engineering degrees (2.33 and 2.3.3.1)

A request was received from Ross Barron from the Nebraska Department of Transportation (NDOT) to discuss Board Rules 2.3.3 and 2.3.3.1 and how they are interpreted when someone works full-time while earning an advanced degree.

Rule 2.3.3 states Nebraska's experience requirement cannot be met until at least forty-eight months after the completion of the first engineering degree, irrespective of the combination of work experience and education credit that may be available for an advanced degree. Associate degrees are not considered when determining a candidate's first degree.

Rule 2.3.3.1 states that a candidate with an EAC/ABET or CEAB-accredited bachelor's degree and who holds a master's in engineering only needs three years of acceptable work experience.

Discussion was held regarding individuals who may work full-time while earning a master's degree in engineering. Rule 2.3.3 was written to prevent individuals from obtaining experience while also claiming education credit for earning the master's degree. It was also to assist applicants with any issues that may arise when they apply for comity licensure in other jurisdictions, as most require at least four years of experience.
