Update on PE Nuclear Exam (Presentation from NCEES ABM)

Information on the current state of the PE Nuclear Exam was provided. NCEES proposes to conduct a PAKS study in the fall 2025, to be completed by the fall of 2026. Exam development would occur during 2026-27. A professional society has requested that the exam be moved from October to April. The October 2027 exam administration would be suspended, with the first exam with the new specifications being offered in April 2028.

Professional Engineers Coalition Feedback on Proposal to Remove PE Exam Approval from Act

Feedback was received from the Professional Engineers Coalition (PEC) regarding the Board's proposal to remove the PE exam requirements from the E&A Act to allow for direct registration by the examinees, eliminating the requirement that the Board approve PE exam applications before the individual can register and schedule their exam. The members requested that ED Wilbeck meet with PEC to discuss their concerns. Thiele stated he was available to attend the meeting if needed.

State of the Proposed E&A Act/Board Rules Changes

Chair Dvorak suggested staff look at revising language in Rule 9.2.4 to clarify that courses related to professional development may not be eligible for continuing education credit. The rule currently allows any topic that falls within a professional society's body of knowledge to be eligible. After researching some of the engineering societies' bodies of knowledge, it was found that some list topics related to professional development that may not be related to health, safety, and welfare, or are not technical in nature. Several of the members felt the current language may be too broad.

Staff will look at Rules 9.2.1, 9.2.2, and 9.2.4 and bring suggested revisions to the October meeting.

NCEES Revising Engineering Education Standard

ED Wilbeck provided an internal email to staff directing them to review education evaluations going forward against the revised NCEES Engineering Education Standard—adjusted by the NCEES Council at the 2025 Annual Meeting—from this date forward, and regardless of when the evaluation was performed.

Update on Licensee Database Replacement Project w/NCARB

ED Wilbeck updated the members on the status of the database replacement project.

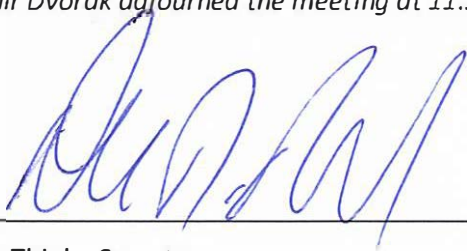
