CALL TO ORDER

The December 12, 2025, meeting of the Nebraska Board of Engineers and Architects (NBEA) was held at 215 Centennial Mall South, Lincoln, Nebraska. Chair Dvorak called the meeting to order at 8:31 a.m. and noted the location of the Open Meetings Act. A draft copy of the committee's guidance document on registered interior design practice overlap with architecture, incorporating the changes requested at the September meeting, was provided. ED Wilbeck provided an alternate language draft.

ED Wilbeck provided an updated bill draft of the proposed statute revisions.

A copy of correspondence received from the Professional Engineers Coalition (PEC) was provided regarding the Board's desire to move to direct registration for the Principles and Practices of Engineering Exam (PE) exam. PEC has indicated that it believes the Board should remain the ultimate authority to approve candidates for the PE exam.

Legislative liaison Russell Westerhold of Edward Westerhold Moore, spoke with PEC's lobbyist and provided him with a copy of the draft bill. PEC's lobbyist expressed a concern that moving to direct registration for the PE exam may create a dynamic where individuals who are not qualified for licensure may become licensed if the Board is not closely reviewing and approving exam applications. Russell is attempting to set up another meeting with PEC to further discuss the matter.

Discussion was held regarding whether the Board would proceed with the other statute revisions if it decided not to move forward with direct registration of the exam. Consensus was most likely not, as the other revisions are of a housekeeping nature.

Discussion was held regarding the requirement to seal the first and last pages of specifications, reports, and studies in Neb. Rev. Stat. 84-3437.01(4), as in most cases, they contain the same information. It was agreed that only one is required and to delete "and last" from the statute.

"...and the first ~~and last~~ pages of specifications, reports, and studies in such a manner..."

ED Wilbeck and Westerhold met with Senator Lonowski; he is willing to be the bill sponsor.

The Board approved the legislative bill draft to move forward with introduction and authorized the Legislative Committee to use its discretion in making revisions if new information arises after the bill is introduced.

Other Reports

Russell Westerhold informed the members that the 2026 legislative session is scheduled to begin on January 7, 2026. The last day for bill introduction is January 20, 2026. He believes the focus will be on the state budget deficit, with bills from other agencies to raise fees aimed at generating additional revenue.

C. OLD BUSINESS

State of Board Rules Changes After October 2025 NBEA Meeting

A copy of the proposed rules incorporating the changes discussed at the October meeting was provided. Additional recommended revisions include:

- Revising Rule 9.4.2.4 to use the NCEES Model Language
"With respect to Rule 9.2.3.4, credit for teaching or presenting an activity may be credited double the number of actual hours. Credit is valid only for the first offering or presentation. Full-time faculty may not claim teaching credit associated with their regular ~~teaching~~ duties."
- Adding Rule 9.4.2.11 to read, *"Regular duties are not considered qualified activities."*
- Revision to Rule 9.4.3 to delete the second sentence to clarify the Board's intent that carry-over credits can only be used if they were gained in the previous renewal period.
"Architects and professional engineers may carry up to one-half of the required continuing education credits from the previous biennial period. ~~Excess credits can be carried over only into the biennial period immediately following the period in which the credit was earned.~~"

UNL-Department of Civil and Environmental Engineering Proposed Rules Feedback

Correspondence from the UNL Department of Civil and Environmental Engineering regarding rules related to experience credit for advanced degrees. The department recommends changes to Rules 2.3.3 and 2.3.4. In Rule

2.3.3, they suggest removing the requirement that an individual must wait at least forty-eight months after completing their first engineering degree. The rationale provided is that since UNL now offers accelerated MS degrees, students may earn a master's degree in civil engineering just one semester after receiving their bachelor's degree. They also recommend modifying Rule 2.3.4 stating that individuals without a degree from an EAC/ABET- or CEAB-accredited program be granted the same experience credit for graduate degrees as those with an accredited degree.

A copy of the NCEES Model Law language, along with responses from other states regarding experience and education credit during the same period, was provided.

Discussion was held regarding the increase in accelerated master's programs across the country. The current rule language was promulgated to alleviate the administrative burden of reviewing time sheets. Concern was also raised about how to determine whether a program is accelerated or not. Consensus was that the subject needs to be addressed at the national level before implementing any revisions at the local level. ED Wilbeck will follow up with the university to gather more information and to continue the conversation.

Discussion was held regarding allowing experience credit for foreign or non-accredited degrees. It was determined that both subjects would be better discussed during the 2026 Operational Planning meeting.

Suelter left the meeting at 9:53 a.m.

ED Wilbeck updated the members on the status of the database replacement project.

[ICOR Practice Overlap Report](#)

A copy of the final *Interorganizational Council on Regulation* (ICOR) practice overlap guidance document was provided. The guidance document addresses the issue of overlapping practices among licensed and/or certified design professionals in architecture, engineering, interior design, landscape architecture, and surveying. It represents a cross-profession effort to bring clarity, consistency, and transparency to overlapping practice. It is intended to support regulators, code officials, and practitioners in ensuring that only qualified individuals perform regulated tasks, while promoting interdisciplinary collaboration in the interest of public protection.

Foley, who served on the Task Force's Steering Committee, reminded the Board that the document does not hold the force of law; however, he states that boards could use it as a reference when determining whether someone is practicing outside a defined scope of practice or beyond their competency.

ED Wilbeck noted that ICOR hopes that each of the organizations involved in the project will present the guidance document to their member boards, and it remains to be determined whether NCEES or NCARB will address creating model language related to practice overlap.

A trade name exemption request was received from Ontic Engineering and Manufacturing Inc (Ontic) to use the term *engineering* in its trade name. The organization has a remote employee living in Nebraska and has applied for registration in the state to comply with payroll and state unemployment insurance requirements.

The organization manufactures, sells, and supports aviation and aerospace components and sub-systems for commercial and military platforms in the US and abroad. It states it does not perform any engineering and does not employ professional engineers. The remote employee supports a sales function.

NCEES Survey re: MBA on NCEES Board of Directors

A survey from NCEES has been received requesting input on the feasibility of adding a Member Board Administrator (MBA) Position to the NCEES Board of Directors. Preliminary qualifications are:

- The candidate must have served as an MBA of a member board for at least four years and completed either (a) three years of active participation in zone and national meetings, or (b) three years of services on an NCEES committee during that timeframe.
- The elected MBA shall serve a one-year term, which will rotate among zones. At no time will a zone have back-to-back nominees. A zone may nominate multiple individuals for the position.
- If the position becomes vacant, the Chair of the MBA committee will serve as the MBA on the Board of Directors for the remainder of the term.
- The MBA shall be a full-voted member of the Board of Directors.
- Nominations must be submitted to the NCEES staff liaison for MBAs no later than May 30th for a July 15th election by email ballot. All member boards will be allowed one vote.

The members directed ED Wilbeck to answer yes to all questions and recommend that the position be a two-year term and the individual be appointed by the member board administrators. On a related note, the Board suggests adding a comment that it would support adding public member board members.

2026 NCEES Central/Northeast Zone Meeting Funded Delegate Selection

Policy P21.01 & P24.03 Deletion

Policy P21.01 addressed license renewals for those selected for continuing education audits. As audits have been separated out from the renewal process and are no longer required for renewal, the policy is no longer needed. Policy P24.03 addressed the sealing of large specifications involving the work of multiple licensees, where it may be cumbersome to coordinate the sealing of the first and last page of each specification section. The policy was promulgated as Title 110 NAC, Rule 6.1.5.1, and became effective on November 25, 2025.
