Russell Westerhold, Edwards Westerhold Moore, reported on the 2026 legislative session. The main budget bills, LB1071 and LB1072, have advanced to E&R Engrossment. It has been estimated that the state will start FY2026-27 with an eight-million-dollar deficit. Westerhold and ED Wilbeck have approached Senator Riepe to possibly amend LB899 into LB1212, which is currently in E&R Initial. LB1212 addresses internationally trained physicians under the Uniform Credentialing Act.

C. OLD BUSINESS

State of Board Rules Changes After January 2026 NBEA Meeting

A copy of the proposed rules incorporating the changes discussed at the October meeting was provided. No discussion or action taken.

NCARB 2026 Draft Resolutions for Consideration

A copy of the draft 2026 NCARB Resolutions was provided. Discussions occurred during the NCARB Regional Summit in Oklahoma, OK, March 20-21, 2026. The NCARB Board of Directors will review and revise as needed at the April Board of Directors meeting. The final resolutions will be distributed before the annual meeting in June. No action taken. It was noted that the mutual recognition agreements are now written with an opt-out option for each member board, rather than requiring each member board to opt-in.

NCARB funds two professional board members, one public member, one board executive, one legal counsel, and one new board member appointed after July 1, 2025, from each member board to attend the 2026 NCARB Annual Business Meeting. To protect the integrity of license numbers and to combat seal fraud, the Board will not provide license numbers in its website licensee lookup.
