ED Wilbeck provided an updated copy of the proposed rules revisions after the discussion at the May 2026 Operational Planning meeting. After discussion, the following revision was made to Rule 9.3.2.1:

Web-based or pre-recorded offerings including webinars, video conferences, and online meetings led by an instructor that enable both the instructor and attendees to give, receive, and discuss information in real time, are not restricted under Rule 9.3.2.

Post-NCARB Annual Business Meeting Recap

ED Wilbeck updated the Board on the previous NCARB Annual Business Meeting held in Minneapolis, MN, on June 25-27, 2026. All the proposed resolutions were passed by the member boards. John Rodemacker was elected NCARB President and Kelly was elected Region V Chair.

Update on Licensee Database Replacement Project w/NCARB

ED Wilbeck updated the Board on the status of the database replacement project.

D. NEW BUSINESS

NCEES Action Items and Conference Reports

A copy of the action items and conference reports for the NCEES annual meeting to be held in Henderson, NV, August 18-21, 2026, was provided. The following motions were discussed:

ED Wilbeck commented that he saw no issues with any of the Special Committee on Bylaws motions and recommends support for all.

- **Motion ACCA 6-8** – Gives the Uniform Procedures and Legislative Guidelines (UPLG) committee the ability to develop language related to any motion to amend the Model Law and Model Rules and present them to the Board of Directors for acceptance without the full vote of the member boards. ED Wilbeck supported the Board of Directors' rationale. After discussion, it was determined to oppose the motions.
- **Motion ACCA 10** – adds the ability of a permanent US resident to hold a Board of Directors position. ED Wilbeck questioned whether NCEES had asked legal counsel regarding the addition. After discussion, it was determined to take a neutral position on the motion.
- **Motion Education 2** – Charges the ULPG Committee to incorporate into Model Law Appendix D 130.10 B.3.a the requirements for structural licensure. Several members recommended opposing the motion. ED Wilbeck recommends opposing the motion due to the inclusion of the ETAC/ABET degree, which would further strain staff and Board time. Dvorak also questioned who is qualified to determine whether an ETAC/ABET PhD dissertation contains sufficient structural matter for acceptance. After discussion, it was determined to oppose the motion.
- **Motion EPP 4** – Amends Examination Development Policy 4A-C to include updated language related to reinstating discontinued PE examinations. After discussion, it was determined to support the motion.
- **Motion Law Enforcement 1** – Charges the ULPG Committee to amend Model Law 130.10 A.1 to include *acting ethically with integrity, honesty, trustworthiness, and accountability*. ED Wilbeck pointed out that the language is not written as a statutory definition and should not be included in the Model Law language. Suelter explained that the language was added to clarify trustworthiness and honesty as justification for NCEES to act if a compliance issue arose with a licensee. After discussion, it is believed that Model Law 130.10 should stand as is. The members determined that the motion should be taken off the consent agenda and opposed.
- **Motion Licensure 3** – Revises the definitions of signature, electronic or digital signature, and seal. ED Wilbeck believed the language could be improved, but should be supported in accordance with Board Rules. After discussion, it was determined to support the motion as written.
- **Motion Licensure 5** – Strikes Model Law 140.30 related to the issuance of duplicate certificates. ED Wilbeck strongly opposed, stating that statutory authority should always be provided whenever a board

requires a fee. After discussion, it was determined to remove the motion from the consent agenda and oppose it.

- **Motion Licensure 10** – Adds a waiver of the FE exam for applicants with a PhD. The Board of Directors opposes the motion as it is one of the least common exemptions across the member boards. It was determined that the Board will oppose.
- **Motion MBA 1** – Adds a Member Board Executive position to the Board of Directors. A discussion was held to consider presenting alternative language to make the current non-voting Member Board Executive, along with the public member, a voting member. After discussion, it was determined not to present alternative language and oppose the motion.
- **Motion SPTF 1 & 2** – Incorporates language related to *significant structures* into the definition of practice of engineering and adds a definition for *significant structures*. After discussion, it was determined to support the motions.

Motion by Suelter, second by Brisnehan, to authorize the voting delegate to vote on the motions as discussed. Voting Yes: Brisnehan, Dvorak, Foley, Kelly, Reed, Suelter, Thiele; Voting No: None; Absent: Bostelman

Motion by Foley, seconded by Suelter, to appoint Dvorak as the voting delegate, Thiele as the backup, and to authorize the attending delegates to use their discretion based on information and discussion provided at the meeting. Voting Yes: Brisnehan, Dvorak, Foley, Kelly, Reed, Suelter, Thiele; Voting No: None; Absent: Bostelman

F. FINANCIAL MATTERS

Governor's Fiscal Restraint Memo

Governor Pillen issued a memo on July 8, 2026, ordering all agencies, boards, and commissions to exercise additional fiscal restraint, including travel, hiring, membership dues, technology upgrades, and equipment purchases. The order pertains to all agencies, regardless of whether an agency receives funds from the General Fund or by other revenue means. The following are being implemented:

- Hire Freeze – mission-critical positions may be hired with an exception approval from the State Budget Division
- Monthly allocations are being reduced by 5% in aggregate for FY2026-27 pending further consideration and determination of the deficit budget adjustments by the Legislature during the upcoming 2027 legislative session.
- All agencies, boards, and commissions are expected to submit monthly cash flow projections to the State Budget Division. The projections are also to identify appropriation strain initiatives. Submittals are due to the State Budget Division no later than July 31, 2026.
