With the advent of computer-based testing (CBT) in 2014, the need for continuing university visits to sign up FE examination applicants was questioned by staff. The Board suggested continuing visits for informational purposes even though applications are no longer required. Events such as Career Fairs or E-Week could be utilized to present information to students. Using a flat-screen television for videos or power point presentations was suggested. AA Lais asked the Board how it preferred to report examination scores, since examinees will be able to obtain their CBT scores on the NCEES website. After discussion, it was decided a final letter will be mailed after exam(s) for ARE or FE examinees are successfully completed to outline the next steps. A Board policy for processing ARE and FE examination results will be created for review at the October meeting. Neighboring jurisdictions will be contacted to ensure licensure requirements are the same so licensees can become licensed in bordering states.

PIO Fetterman reported on plans for the 2013 New Licensee Ceremony. It will be held at the Warner Chamber of the State Capitol on November 8, 2013, at 2:30 p.m. PIO Fetterman reported Lt. Representatives of the American Institute of Architects (AIA Nebraska) and Nebraska Society of Professional Engineers (NeSPE) are prepared to give remarks.
